Please read this agreement carefully. HVS leased equipment is subject to the following rental terms and conditions.

### General Lease Information:

All leased equipment returned to HVS must be in Original as received condition (free of scratches, dirt and abuse). All equipment must be protected from damage and operated in a safe manner. The undersigned is responsible for the operation, care, maintenance and safety of the equipment during the rental period. Any personnel operating the equipment must be properly trained and qualified to operate equipment. Applications involving corrosive materials, high concentrations of oxygen, hydrogen, or nuclear materials are prohibited. The equipment is to be used for applications which do not adversely effect, nor cause damage to the equipment. The customer is responsible for all damage resulting from exposing the equipment to potentially damaging conditions. The customer will be responsible for repair or replacement of equipment under the above referenced conditions. HVS solely will make the determination of services and parts required to restore equipment to original and proper working condition.

Please review the operating instructions for the equipment before operating. Follow all start up, safety and shut-down procedures as outlined in the operating manual. HVS does not guarantee or certify any leak testing results generated by the rental equipment. The user is responsible and liable for leak testing certification and results.

This lease does not include installation, on site instruction or service. All required services on the above referenced equipment will be billed at the standard service rates in affect at the time the lease is executed.

### Rental Rates and Fees:

All rentals require credit card payment or an existing Open Account. Contact HVS to arrange for alternate terms of payment. Rental charges will begin on the day the item is shipped or picked up by customer. The rental will end on the day the item is received at HVS facility. HVS allows for up to 2 calendar days in each direction for shipping. Any additional time in transit counts toward the rental period. Rental fees are charged upon shipment of the rental equipment. Additional fees due to extended or late rental returns will be charged upon return or upon the request for additional time, at HVS discretion. Rental term will renew automatically for term originally contracted upon expiration of original term. Credit will not be provided for early returns (1 week minimum) or for lack of usage.

The undersigned is responsible for damage, loss or theft of the equipment during the rental period. Identification of any possible hidden damage is subject to inspection by HVS. When operated properly the equipment should incur minimal wear and tear during the rental period. If it is determined that upon receipt and inspection of the returned equipment there has been excessive wear and tear or abuse the customer shall be charged for repair. This includes but is not limited to contamination of equipment by chemicals, water or excess particles or running the equipment without the proper type or amount of lubricant. The undersigned is responsible for payment of reasonable costs to repair or replace the equipment due to damage, loss or theft. It is highly recommended to verify business insurance coverage of rental equipment in possession. HVS reserves the right to charge the provided credit card to cover the damage, loss or theft of the rental equipment.

### Service and Repairs:

The undersigned is not authorized to perform repairs or maintenance on the equipment. All repairs or maintenance must be performed by or under the direction of HVS personnel. In the event of equipment failure or operational questions please contact HVS for technical support. Warranty replacement units will be provided at no additional charge in the event of a rental failure, however, the user is responsible for all shipping to and from HVS facility for this unit as well as unit originally supplied.

### Transportation, Storage and Shipment:

The equipment shall be packaged to prevent damage due to shock, excess vibration and weather during storage, transportation or shipment. Supplied shipping containers must be returned. All shipping charges to and from HVS facility are to be paid by the customer. All items to ship insured per the indicated value. Leak detectors and vacuum pumps are due back within 2 calendar days of end of rental period, any delays for any reason may result in additional rental charges. Leak detectors not received within allotted time are subject to a \$150 per day surcharge. Vacuum pumps not received within allotted time are subject to up to a \$50 per day surcharge.

HVS provides shipping, crates and/or pallets to minimize the possibility of shipping damage. The equipment must be returned in the way it was shipped to you. If not, a lost crate/pallet fee will apply. **You should not ship leak detectors via UPS or Fedex package services unless it was shipped to you in that manner or with HVS approval.**

**Warranty:** This warranty is in lieu of any other expressed or implied warranty. HVS assumes no liability in any event for: consequential damages, anticipated or lost profit, incidental damages or lost time or any other loss incurred by the user or any third party in connection with the use of this rental equipment.

This agreement shall supersede the terms and conditions of any purchase order issued to HVS. The terms of this agreement are not negotiable nor subject to change. If any term or condition of agreement is voided by law the remainder of terms and conditions still apply.
